





Common Site Challenges Identified

- Investigators had difficultly keeping track of different study inclusion and enrollment criteria
- Investigators were not comfortable speaking to patients about studies because they were unclear of the details (i.e. # of visits, length, stipend)
- Coordinators were not always available to have these conversations with patients during clinic

Research Hive helps investigators refer subjects to the study team and to track those referrals.




Research Hive facilitates a thorough informed consent discussion with printable consents.

























The Results: What Happened to a "good" site?



- The site was selected to participate in the world-wide TIMI 61 trial. Enrollment began in 2014.
- With 215 randomized subjects, the site became #1 in the world.
- Enrollment has closed, and subjects retention is facilitated using the Research Hive platform.
- Following a monitoring visit in Q2 of 2015, the sponsor has requested the site to continue to use the Research Hive for the duration of the trial, citing improved communication of SAE's.

Why it Works

- Investigators use their smart phones
- Only the most current, IRB approved material is available to the team
- SAE's are often discovered during rounds, at night
- The whole study team has access to all study resources to become well versed in protocol and procedures

- Study staff are busy and on the move between locations
- Push notifications for SAE's and referrals are 'top of the inbox' get immediate attention from coordinators
- O Updates to protocols are pushed immediately to all study staff



Subscription to Research Hive

- Low subscription fees, charged per referring provider only
- ALL staff are free, no matter how many staff are involved
- No setup fee, no data entry fees Research Hive enters
 ALL study data for ALL sites
- Referring providers defined as anyone who refers patients to the site and have the app installed, whether they are in the same institution or outside. (HUGE potential benefit to gain more referrals from 'outside referrers.")

Deployment is Easy for Pharma or CRO

Pre-Study:

Research Hive deployment team attends investigator meeting and presents/trains on-site

Mid-Study:

Webinars for recruitment strategies introduce Research Hive - RH team schedules individual site-level meetings CRA's are trained during webinars to briefly introduce Research Hive during site visits, RH team follows up to schedule site webinar

- Research Hive creates the site's FULL database to further encourage app usage
- Users download the app from iTunes store and Google Play
- Research Hive provides live telephone support for sites
